# MINUTES OF THE SPECIAL GENERAL BODY MEETING OF HIND CO-OPERATIVE HOUSING SOCIETY LIMITED HELD ON 30<sup>TH</sup> JUNE ,2024

The Managing Committee were present at 10.30 a.m. but since there was no quorum. The meeting was postponed. The meeting started at 11.00.a.m. sharp by the Hon. Secretary.

The meeting was presided by the Chairman, Mr. Rupesh Shetty.

The Second Agenda was discussed on Priority basis as Mr. Godse, the guest had some other appointments and had to leave by 11.30 a.m.

To update the members about the progress of documents received from Collector's office and speeding up process of Redevelopment.

Mr. Bansi Thapar, the Hon. Secretary, introduced Mr. Godse, who is a Chairman of similar type of buildings and dealing in similar situations.

Mr.Godse explained the Redevelopment process and he showed his willingness to share his experience of Redevelopment and give necessary guidance wherever required.

Mr. V.S. Srinivasan (Flat B/43) raised his hand and asked about the conveyance deed of the land. Mr. Godse explained about this conveyance deed for the society. Subsequently Mr. Ramesh Lalwani (Flat A/07) raised his hand and enquired whether the Lease deed of the Society is executed. Mr. Rupesh Shetty, the Chairman, explained regarding the same to Mr. Ramesh Lalwani.

The Managing Committee thanked Mr. Godse for coming to the meeting and enlightening the House on Redevelopment process. After concluding the discussion of Redevelopment Mr. Godse left.

The Managing Committee explained how the documents which were missing since 45 years were collected through RTI, also there was a written communication from Collector in the year 1993 to society to come and complete the process, but it is understood that then MC didn't handover the above said documents to the next Committee.

Mr. Bansi Thapar, the Secretary, explained that we need Rs. 25 Lakhs sanctioned for the Redevelopment process, which was sanctioned in the Special General Meeting dated 31<sup>st</sup> July 2022. The 1<sup>st</sup> and 2<sup>nd</sup> installments of Rs 1000/= as approved by the House were taken in the month of August & September 2022 of which Rs. 5 Lakhs were collected. Now Rs. 20 Lakhs remains to be collected. The Members raised their hands in approval for addition of Rs. 1000/- per month in their maintenance bill from July 2024 onwards.

To this Mrs. Darshana S. Kanoujia of Flat A/92 raised objection and said that she did not trust the present Committee for which Mr. Kunal Valia of Flat D01/D02 said he had full trust in the present Committee and she should not interfere with these matters as whatever decision has to be taken immediately as the members' life is at stake.

The MC told that Mr. Mahinder Punwani of D-56, who was whistle-blower, informed them regarding cracks developed on the beam and wall of his flats and subsequently Mr. Kale, our Structural Auditor, who had done the Society's Audit was called. He said that this is new settlement and it is beyond their Capacity to do any repair work. Then on Managing Committee member's suggestion, they called for Mr. Chindarkar of REHAB Consultants, who visited the premises, asked in to go for Soil Test. He also suggested that the water from Overhead tank of 'D' & 'E' wings to be removed from the terrace as it is putting more burden on the building. He also told to put Props for supporting the Pillars. The Managing Committee followed the instructions immediately and did the needful. Mr. Chindarkar said the Visual Records to evaluate 'D' & 'E' wings, as he will not be able to consult.
